

TO ASSIST US WITH MAXIMIZING VISITATION POTENTIAL WHILE ALSO KEEPING OUR RESIDENTS AND STAFF SAFE, WE ASK THAT YOU SCHEDULE YOUR VISIT AT LEAST 24 HOURS IN ADVANCE.

WHAT TO EXPECT

- ➔ RESIDENTS ELIGIBLE FOR VISITORS MUST BE FREE OF COVID-19 AND SYMPTOMS AND THEY CANNOT BE IN A QUARANTINE PERIOD.
- ➔ WE ENCOURAGE VISITORS TO HAVE A COVID-19 TEST within 2–3 days prior to coming to the facility for the ongoing safety of our residents and staff.
- ➔ VISITS WILL TAKE PLACE IN DESIGNATED VISITING AREAS. Outdoor visits (weather permitting) are preferred but indoor visits are permitted. Residents without a roommate may have visitors in their room. Please remain in designated visitation areas.
- ➔ The NUMBER OF VISITORS PERMITTED IS LIMITED BY THE MAXIMUM CAPACITY OF THE ROOM taking in to account privacy and safety, including social distancing.
- ➔ ALL VISITORS ARE REQUIRED TO BE SCREENED. Upon arrival you will be screened for all symptoms related to COVID-19, including questions related to exposure and vaccination status.
- ➔ All visitors are required to sign in and PROVIDE CURRENT CONTACT INFORMATION. If you should become ill within 14 days of your visit please notify us at 570-655-2891 Ext x5243.
- ➔ YOU WILL BE ASKED TO USE HAND SANITIZER, which will be provided prior to your visit.
- ➔ A MASK OR FACE COVERING THAT COVERS YOUR NOSE AND MOUTH MUST BE WORN AT ALL TIMES throughout the visit*. This includes travel to and from designated visitation areas. Visitors are asked to bring their own mask. This includes anyone ages 2 and up. (Note exceptions below.)
- ➔ *If a RESIDENT IS FULLY VACCINATED, the resident can choose to have CLOSE CONTACT (INCLUDING TOUCH) WITH THEIR VISITOR WHILE WEARING A WELL-FITTING FACE MASK AND PERFORMING HAND-HYGIENE before and after.
- ➔ *If a RESIDENT AND THEIR VISITOR ARE BOTH FULLY VACCINATED, the resident can choose to have CLOSE CONTACT WITH THEIR VISITOR (INCLUDING TOUCH) WITHOUT WEARING FACE MASKS ONLY IN DESIGNATED VISITING AREAS.
- ➔ We ask that all visitors continue to physically distance from other residents and staff in the facility.

Any new COVID -19 case will pause visitation (other than compassionate care visits) temporarily. Visitation information is posted on our website and you will be notified via our ReGroup alert system.

Failing to adhere to these protocols will prohibit you from visiting.
